- Box and void-fill paper: sales packaging.
- Plastic bag and desiccant sachet: part of the product packaging.
- Single-use packaging; not intended for food contact.

5. Declaration of conformity

The object described in point 4 complies with the requirements of Regulation (EU) 2025/40 on packaging and packaging waste that are applicable at the time of issue.

According to the evidence listed in the technical documentation, the sum of the concentrations of lead, cadmium, mercury and hexavalent chromium does not exceed the applicable limit of 100 mg/kg.

The specific PFAS limits for food-contact packaging under Article 5(5) do not apply to this packaging, as it is not intended to come into contact with food.
